

AN ORDINANCE AMENDING A FEE SCHEDULE FOR SERVICES AND RECORDS PROVIDED BY THE RIPLEY COUNTY HEALTH DEPARTMENT AND REPEALING ALL PRIOR FEE SCHEDULES INCONSISTENT THEREWITH

WHEREAS, Indiana Code Sections 36-1-3-1 et seq. permit any County in the State of Indiana to exercise any power or perform any function necessary to the public interest in the context of its municipal or internal affairs, which is not expressly granted by any other law to another governmental entity;

WHEREAS, the Board of Commissioners of the County of Ripley, Indiana is the County executive and legislative body and is by law authorized to adopt ordinances and resolutions for the performance of functions within the County of Ripley, Indiana;

WHEREAS, the Board of Commissioners of the County of Ripley, Indiana is by law authorized to approve fee schedules for the services and records provided by the Ripley County Health Department pursuant to Indiana Code Section 16-20-1-27;

WHEREAS, the Ripley County Board of Health has requested that the Fee Schedule currently used be replaced by a new Fee Schedule which better reflects the costs of such services and records provided by the Ripley County Health Department;

WHEREAS, the proposed fees in the new Fee Schedule have been studied and examined by the Ripley County Health Department to determine that such fees are not in excess of the cost of services rendered;

WHEREAS, the proposed fees in the new Fee Schedule have been adopted by the Ripley County Board of Health after opportunity was given for public comment on the proposed fees;

WHEREAS, pursuant to the authority vested by Indiana Code Sections 36-1-3-1 et seq. and Indiana Code Section 16-20-1-27, the Board of Commissioners of the County of Ripley, Indiana does hereby approve and establish a new Fee Schedule governing the collection of fees for the services and records provided by the Ripley County Health Department in accordance with the terms and provisions hereinafter stated;

NOW THEREFORE, BE IT ORDAINED, ORDERED, AND ESTABLISHED by
the Board of Commissioners of the County of Ripley, Indiana as follows:

1. DEFINITIONS. For the purposes of this Ordinance, the following terms shall
be defined as set forth below:

a. "Board of Health" means the Ripley County Board of Health as provided for in
Indiana Code Section 16-20-2-1 et seq.

b. "Health Department" means the Ripley County Health Department.

c. "Person" means any association, company, corporation, firm, individual, or
partnership.

2. COLLECTION OF FEES. The Health Department shall collect the fees for all
services it provides in accordance with this Ordinance.

3. FEES FOR SERVICES. The Board of Health shall charge a fee for providing
any person with the services listed in the Fee Schedule of this Ordinance.

4. COLLECTION OF FEES, ACCOUNTING, AND DISPOSITION.

a. Collection of Fees. The Health Department shall collect the fees established by
this Ordinance in accordance with Section Five (5) below.

b. Accounting for Fees. All fees collected by the Health Department shall
be accounted for in detail for each program service area.


c. Disposition of Fees. All fees collected by the Health Department
pursuant to this Ordinance shall be transferred to the Ripley County Health Fund.
The monies collected in accordance with this Ordinance shall be used only for the
maintenance or future expansion of the specific program service areas from which
they are derived.

d. Fees for Other County Health Jurisdictions. Fees collected for health services
and records provided to persons in other county health jurisdictions and involving
payment from Ripley County tax revenues shall be collected in accordance with
agreements entered into pursuant to Indiana Code Section 16-20-1-8.

5. FEE SCHEDULE. The Following Fee Schedule is established and approved for the
services and records provided by the Health Department:






